- 1. I. Robert Hogg or Hoge, born November 1721, a native of South Scotland, emigrated in early life to County Down, Province of Ulster, Ireland. He came to America in 1752. In the spring of 1754 he located on a tract of land in the Tuscarora Valley, then in Cumberland County, Province of Pennsylvania. In June 1756, owing to the Indian incursions upon the Juniata, Mr. Hoge fled with his little family to Carlisle, returning only in the fall of that year. On two other occasions did this early pioneer seek safety in the then principal place of refuge west of the Susquehanna. He died on his plantation the 25th of January, 1798, aged eighty years. His wife Letitia \_\_\_\_\_, born June 1724 in the north of Ireland; d. March 8, 1812, in Juniata County, Penn. and with her husband buried in what is now known as the "McKee graveyard." - II. Jarah Hoge (Robert), b. May 1753, in the city of Philadelphia, Penn. d. June 26, 1828, near Materford, Juniata Jounty, Penn. The was a remarkable woman in many ways, a most estimable wife and mother. The was twice married; m., first, in Tuscarora Valley, 1778, George McCullough, b. 1751, in County Down Ireland; d. in the year 1783, his death resulting from the bite of a rabid dog. Mr. McCullough came to America prior to 1774, with his cousins Thomas and John Mckee, and settled in the Tuscarora Valley. Men the war of the Revolution broke out, he sided with the patriots of his locality, and served during the greater part of the struggle for Independence. He left issue (surname McCullough).

### WNotes by Leonard Lytle

"The following is a copy of an original document belonging to Mrs. Lettitia A. Harnish of Alexandria, Pa. She is the grand-daughter of Robert and Letitia Lytle. It was written by James McKee Lytle, their son. For five years prior to Lettitia Lytle's death, in 1864, she was blind.

"STATEMENT OF LETTITIA LYTLE, WIDOW OF ROBERT LYTLE DEC. NOW LIVING AT ALEXANDRIA HUNTINGTON COUNTY, PENNSYLVANIA."

I am the daughter of George McCullough, who came from Ireland

- iii. Robert, b. 1792, d. 1859, near Logansport, Ind. Of his children, Matthew K. was a lieutenant in 46th Indiana Regt., and d. at Helena, Ark. during the Rebellion; while Issaiah A. served in the 9th Regt., Illinois Cavalry.
- III. Martha Hoge (Robert) b. Dec. 1759, in Tuscarora Valley, Juniata Co. Pa. d. July 1836, near Butler, Pa. She m. in 1778, Thomas McKee, b. 1749 in County Down, Ireland, d. 1814, in Butler County, Penn. He came to America in 1774 and located in the Juniata Settlement. At the commencement of the struggle for Independence he entered the service, and was under Morgan in the Southern campaign, in the Pennsylvania company attached to the corps of that brave partisan leader. His canteen and powder horn, carried through the war, are in the possession of his grandson Lieut. Col. J. Cooper McKee, Surgeon, J.S.A. In 1795 the family removed to Allegheny County, Penn. and the year following 1796 permanently settled on a farm near Butler, Butler County, that State. They had issue(surname McKee)

to America prior to the Revolution. He was a stone mason by trade, landed at Philadelphia and from there went to Northumberland, to erect a barn for a Quaker, when so employed he was drafted, by the draft on the Militia, I think from the information I received this was about the year '74. Inen there engaged he met with Jno. Mckee and some other acquaintances who were living in Tuscarora Valley, and whom he accompanied nome after the service of the draft, when there he became acquainted with my mother, Sarah Hoagg, in the year '75 whom he married and there he resided when he again was called into service, about the year '76. After serving his time he again returned nome. and continued at farming, until again called out in '78, Hugh Gray was with him in '78, and according to the family record I was born in Feb. '79, after his return from the war. He died in Sept. '84 leaving but two children living, Lettitia and Ann, the latter 2 years younger than the older, My mother again married a man of the name of Hamilton Grimes, in the year of '89, by whom

she had two sons and a daughter, named Robert, George and Jane, and lived on in Tuscarora Valley to her death which took place some where in the year '29 or '30. I the oldest daughter of the first husband was married to Robert Lytle on the 6th July 1802 (by the Rev. Mr. Coulter, a Presbyterian Preacher) and lived with him until the day of August 1847 when he died at Hollidaysburg Blair County, Pa. My sister Ann McCulloch married Moses Sturgeon in 1800 and lived with him until 1850, when he died. She died in 1851, both died in Shelby County, Ohio."

June 1, 1754, in County Down, Ireland; d. Nov. 10, 1830 in Spruce Mill Twp., Juniata Co., Penn. He was first cousin to Thomas McKee and George McCullough, and came to America in 1774. He entered the Continental service during the war of the Revolution, Mrs. McKee became widely known in the famous Grey land suit, in which she was the principal witness. Her last years were spent with her daughter Mary, wife of James McKee. They had issue (surname McKee).

information from which this manuscript was prepared by Dr. Egle. Miss Catherine I. Egle informs me that she cannot find the papers on the Sturgeon family and thinks they may have been sold. In order to preserve what information I have on the Sturgeon family I give the following extracts from the letters of Mrs. Margaret Townsley:

"Letitia McCullough was the only sister of Ann McCullough, wife of Moses Sturgeon, and their daughter Lettitia Sturgeon was my mother. She first married John Campbell of Piqua. Miami Co., Ohio in 1821. To them 2 sons and 1 daughter was born. Mr. Campbell died she again married my father John Dalzell, in 1834 and to them were born two children, myself and a brother who died in infancy."

Thomas Smith, pastor of Cedar Springs Church; they shortly after removed to Pittsburgh, where he become prominent in the organization of the first A. R. Church in that city, one of its first trustees, and one of the original incorporators; as contractor and builder, he erected the first Church edifice for the congregation. They had issue.

The postmaster at Cedarville, Ohio, informed me in 1921 that Mrs. Townsley died years ago and that he thinks ner son John Dalzell Townsley is now living in Kansas City. I have not been able to get in touch with him.

<sup>&</sup>quot;My mothers name was Letitia, by that ever dear and loved name we called our daughter, Orrel Lettitia. She died at the age of 2 years and 3 months. Of our four children we have but one living, a son John Dalzell Townsley, now 25 years of age, residing in Dayton, Montgomery Co., Ohio, there in business but not married."

July 20, 1864, in Alexandria, Penn. at the residence of her daughter, Mrs. Stitt; interred at Hollidaysburg; She married July 6, 1802, at the home of her grandfather Hoge, Robert Lytle, b. Hov. 10, 1778 in the Juniata Val.; d. Aug. 15, 1847, at Holligaysburg, son of Capt. John Lytle. He first resided at Cedar Springs, thence removed to Huntingdon, where he engaged in milling and tanning. In 1820 he went to Alexandria, engaging in the same business, until 1841 when he removed to Holldaysburg. They had issue (surname Lytle).

This Captain John Lytle was the John Lytle, wife Grace, associated with John Lukens, Surveyor-General in the land business. They owned land jointly and severally all over western Penn. from about 1760 to 1794. Lytle lived at Philadelphia and at Princeton N. J. He died at the latter place in 1794 leaving a will which is published in the New Jersey Archives, Abstracts of Jills, Vol. 3.

My ancestor was John, who was born in 1755 in Cumberland County. He married Rachel Kenney, He died in 1822 and his will is on file at Lewistown, Pa., showing the children as given above by Dr. Egle. John and Rachel are buried at Mifflintown. Their son John married Mary Lyon for his third wife and there were no children by this marriage. Mary Lyon was a stop-daughter of John Hite. See Appendix.

#This John Lytle is my grandfather. He was born at Johnstown(now called "Valnut"), a village in Hilford Twp., now Juniata County, and removed to Licking Co.OHio about 1828. Simeon Pain or (Paine) and his wife Mary(Triplett) Pain came from Hardy Co., West Virginia to Licking Co. about 1819. My records show that John Lytle was married in Ohio on March 20, 1828 to Terzah Paine the eldest daughter of Simeon Paine. John Lytle laid out the townsite of Lytle City, Iowa, where he had moved about 1850 or 60. He died at Allerton, Iowa, Nov. 12, 1876. His children:

Robert Brice Lytle (my father) was born April 7-1834 on the Simeon Payne farm near Utica, Ohio, died Aug. 28-1911. Raised on a farm at Appleton. Ohio. attended the University of Michigan at Ann Arbor. Commenced teaching when he was only 16, taught at Lansing. I chigan. Jent to Iowa with his father when he was a young man. He was named Robert after his grandfather, and Brice after the pare ts of Senator Brice. He was in his father's store during the time when he was in Lytle City. He was married at Scott, Johnson Co., Iowa, by Rev. Alexander Fairly, June 9th, 1859, to Barah Ellen Kemp, daughter of Jilliam kemp who came from Forres, Scotland, and Mary Moore of Canada. (They were married in Ohio and Sarah Ellen, their daughter, was born in Zanesville, Ohio, Sept.1-1842. Robert Brice Lytle farmed near Solon, Iowa, lived for one year at Cedar Rapids, then moved to Sulphur Springs, Iowa,

Paroled with the Command he returned to Fort Leavenworth and subsequently ordered to Camp Butler, Springfield, Ill., as a prisoner of war on parole, which he reached in April, 1862. In June following he was exchanged, ordered to Washington City, thence to Chester, Pa. to assist in establishing a U. S. General Mospital in that City. In July was ordered to headquarters Army of Virginia, as Assistant Medical Director, Gen. Pope commanding, was on duty at second battle of Bull Run and at Antietam, and director of the hospitals at Frederick City, Md. During 1862 and 1863 continued with the Army of the Potomac as Medical Director. In May 1863 took charge of the Calvery Street Hospital, Baltimore: in June ordered to Pittsburg to establish a General Hospital. and in the autumn of that year, sent to Washington City in command of the Lincoln General Hospital, where he continued until 1865, during which period over 25,000 sick and wounded soldiers were cared for. In 1868 he was ordered to Santa Fe, New Mexico, as Chief Medical Officer of the district; in 1870 to Staten Island, N. Y., and 1873 at Presidio, Cal. In 1876 at Fort Mipple, A. T. Medical Director of the Dept. of Arizona, where he remained until 1880; in 1883 again at Presidio, Brevetted Lieut. Col. W.S.A. for faithful and meritorious service; at Vancouver Barracks, Washington Territory, 1884; and in 1885 at Boston. Owing to an accident, a few years since the Doctor was rendered a cripple for life; is unm. resides at Butler, Penn.

Egles' History of Dauphin Co., Pa. p. 16, gives a list of Scotch Irish signing a petition to Governor of New England Colony for permission to settle there. Being refused they came to Pennsylvania and settled chiefly around Donegal. Robert and James Hogg were signers.

Robert Hogg was appointed Overseer of Poor, Milford Township, March 26, 1770 by Court at Carlisle before Jonathan Hoge, Asq. Reappointed March 25, 1771. See Quarter

Sessions book 3-4, p. 82 and 127.

On March 25, 1775 Robert Hogg was appointed Constable for Milford Township. See Quarter Jessions Book 3-4.

See History of the Susquehana and Juniata Valleys, Vol.. 2, for numerous mentions of Hogg, Lytle, Lokees and others. See especially pages 123, 501, 647, 729, 756, 780, 796, 800, 821 and 833. Also see History of Shenandoah Valley, and the Scotph Irish by Hanna, Vol. 1, p. 457, Vol. 2, p/419 "Hogg does not mean a pig or sow but a lamb a year old."

Ind obtained from the State Land Office at Harrisburg is dated April 11, 1763. On the margin is written "The land for which this warrant is granted having been settled upwards of eight years ago. Interest and quit Rent is to commence

ffom 1st. of March , 1755."

In 1922 I visited Mr. Vm. Graham of Spruce nill, Juniata Co., Pa. He said he was not related to Hamilton Graham but knew George McCullough was a Revolutionary soldier and that he was buried in an unmarked grave beside his wife Sarah in the McKee Cemetery. Mr. Graham and other patriotic citizens had made a practice of placing a flag on the McCullough grave on Decoration Day for many years past.

Mr. C. T. McCoy, Lancaster, Ohio, wrote me that he had a book ready to publish (in 1925) covering the direct descendants of Moses Sturgeon, who married Anna Mc Cullough (See page 2 of Robert Hogg manuscript). He says that Mrs. Margaret Townsley made a large collection of the Sturgegon history and that she sent this to Dr. Egle who arranged it. After Dr. Egle's death this material was purchased from his daughter by a Sturgeon descendant. Mrs. Townsley died in Chicago, June 1915. Moses Sturgeon died May 7, 1850.

A CORRECTION: to statement in manuscript that John Lytle

married a daughter of John Hite. This statement has caused me a great deal of trouble. Frs. Townsley accepted it as correct and I have found it re-stated in other places. Aclying on this I at one time sent out some charts showing the original ancestor of my Lytle line to be John Lytle, married to Rachel, a cousin of President James Buchanan.

If the last lines of the history statement are made to read as follows they will express the facts as proven by me after a thorough search. "Mary Lyon, one of Nite's step-daughters was the third wife of John Lytle, Jr. who ran the ferry at Mifflintown and who afterward moved to Hollidaysburg. He was a brother of Robert of Alexandria and Hollidaysburg, of James who moved to Onio and of David who moved to Jaterloo, N. Y.

In 1939 I learned through Liss Henrietta Baldwin of Mifflintown, Pa. that the county had put a stone marker on George McCullough's grave.

The story of Robert Hogg as published in the History of the Susquehana and Juniata Valleys, Vol. 1, pages, 796-797.

(This History published 1886)

"Robert Hogg, claimed by some writers to be one of the first settlers, had a large tract of three hundred and ninety-three acres warranted April 11, 1763. It is choice land, and is now held by John L. Patterson, George Patterson, William Patterson, Christ Yoder, James Fitzgerald, the latter's mill being on the tract.

"Robert Hogg's daughter, Mary, was married, September 15, 1778, by Rev. Hugh Magill, to John McKer, and they occupied part of the mansion tract. Their children were Robert, Thomas, William, Mary, James, John, Martha, David, Logan and Jarah.

They all left Tuscarora Valley except Jilliam, who married Elizabeth, daughter of Samuel Laird, in 1816. Mrs. Samuel Cooper, of Port Royal, and Mrs. M. Forsyth, of Derry, Mifflin County, are daughters. John McKee laid out on his land a lot for a church and grave-yard. No church was ever built here; but the ground was used for a grave-yard, and here Robert Hogg and wife, Letitia, John McKee and others are buried. It is known as "McKee's graveyard," and is on the farm now Christ Yoder's. Here, therefore, repose the remains of one of the pioneer adventurers into Tuscarora. There is a story that, at the time of the taking of Bigham's Fort, Mrs. McKee and her father (Robert Hogg) were taking some goods across the mountain on a cow, and were seen by the Indians, who let them pass, because they did not wish just then to alarm the fort.

"Although Jilliam Maclay surveyed and returned for Hogg three hundred and ninety-three acres under his warrant, yet this was more than could be held under it. One John kennedy thought he would like to lay a warrant on the surplus. However entered his caveat and they were cited to appear July 28, 1765. Lennedy not appearing, Hogg was heard. The decision was, "That Hour made an improvement on the place in dispute long before Kennedy obtained any warrant for the same, and was driven off by the Indians; therefore Hogg is to have three hundred and ninety-three acres, provided he take out a new warrant for one hundred and fifty acres, but this must not interfere with John Gray." Hogg sold the benefit of this grant to John Mckee June 7, 1786, who warranted one hundred and fifty-One acres inside of Hogg's old lines. The time Hogg was driven off by Indians must refer to 1756, when Bigham's Fort was taken. The reader will note the special tender regard for Hannah, widow of John Gray, that the lines of her survey remained unchanged, and that she be not troubled with any interferences.

"The name of this old pioneer was spelled Hogg in former days. He came from East Pennsborough, in Cumberland County, where numbers of the family spell their name Hoge. Jonathan Hoge was long active and useful in the early days of this State. The tombstones say Robert Hoge died January 20, 1798, aged eighty years. Letitia Hoge died March 12, 1812, aged eighty-eight years. John McKee died November 10, 1830, aged seventy-six years. His wife, "old Mrs. McKee," of the famous law-suit, and only daughter of Robert Hoge, died in the Jest. There is an old path here, crossing the mountain, which was known as Hogg's, and later, McKee's Gap, though there is no depression in the mountain."

Leonard Lytle has an extensive collection of data on his own family. He has also collected much information on some 22 Lytle families not known to be related.

In the History of the Susquehana and Juniata Valleys there are many references to the Hoggs, Lytles, McKees and others. I give, herewith, my index to the 1st Volume there being no mentions that I can find in the 2nd Volume.
